Final Demand Notice: After 60days of non-payment, the debtor will receive a formal Final Demand notice, providing an additional 7 days to settle the outstanding invoice before further legal action is taken.

Legal Action: If the invoice remains unpaid following the Final Demand notice period, the creditor reserves the right to initiate legal action in accordance with Australian legal procedures for debt recovery.
